# GENERAL MEETING OF THE BOARD OF DIRECTORS OF THE CENTRAL TEXAS REGIONAL MOBILITY AUTHORITY

#### RESOLUTION NO. 09-17

WHEREAS, the Central Texas Regional Mobility Authority ("CTRMA") was created pursuant to the request of Travis and Williamson Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.01, et. seq. (the "RMA Rules"); and

WHEREAS, Chapter 370 of the Texas Transportation Code authorizes regional mobility authorities to develop projects through the use of comprehensive development agreements ("CDAs"); and

WHEREAS, the CTRMA solicited proposals for the development of 183-A and in Resolution No. 04-43, dated September 8, 2004, the Board of Directors approved the selection of Hill Country Constructors as the Developer for 183-A, and the CTRMA and Hill Country Constructors entered into a CDA effective November 29, 2004 for the 183-A Turnpike Project (the "Project"); and

WHEREAS, the Project was opened to the travelling public on March 3, 2007 and the CDA was determined to be complete in late 2008, with certain retainage funds being withheld from final payment to address the lack of adequate turf establishment for portions of the Project right of way; and

WHEREAS, the CTRMA has adopted procurement policies (the "Procurement Policies") that provide for various methods for procurement of goods and services; and

WHEREAS, the CTRMA, through its General Engineering Consultant ("GEC") HNTB, undertook the procurement of bids from contractors to provide the remedial efforts necessary to establish turf in the pertinent areas of the Project; and

WHEREAS, four proposals were received, reviewed and evaluated and it was determined that Evans Environmental Contracting, Inc. offered the best value bid to the CTRMA; and

WHEREAS, it is recommended by the GEC and CTRMA staff that the contract for turf establishment for the Project be awarded to Evans Environmental Contracting, Inc., subject to successfully negotiating a contract on mutually acceptable terms and conditions consistent with the procurement documents, the successful response and the Procurement Policies.

NOW THEREFORE, BE IT RESOLVED, that the CTRMA Board of Directors approves of the selection of Evans Environmental Contracting, Inc. to provide remedial efforts to establish turf in the pertinent areas of the Project; and

BE IT FURTHER RESOLVED, that the Executive Director and staff are directed to negotiate and finalize a contract with Evans Environmental Contracting, Inc. on mutually acceptable terms and conditions consistent with the procurement documents, the successful response, the Procurement Policies and this Resolution and that such agreement may be executed by the Executive Director upon its completion under the terms hereof.
