RESOLUTION NO. 10-53

**RESOLUTION AUTHORIZING ACQUISITION OF PROPERTY RIGHTS BY
AGREEMENT OR CONDEMNATION OF CERTAIN PROPERTY IN TRAVIS
COUNTY FOR THE US 290 EAST TOLL PROJECT
(Parcel 10B)**

WHEREAS, pursuant to and under the authority of Subchapter E, Chapter 370, Texas Transportation Code and other applicable law, the Central Texas Regional Mobility Authority (“CTRMA”) has found and determined that to promote the public safety, to facilitate the safety and movement of traffic, and to preserve the financial investment of the public in its roadways and the roadways of the State of Texas, public convenience and necessity requires acquisition of fee simple title to that certain 0.682 acres described by metes and bounds in Exhibit “A” to this Resolution (the “Subject Property”), owned by Jimmy Nassour (the “Owner”), for the construction, reconstruction, maintaining, widening, straightening, lengthening, and operating of the US 290 East Toll Project (the “Project”), as a part of the improvements to the Project, but excluding all the oil, gas, and sulphur which can be removed from beneath the Subject Property, without any right whatever remaining to the owner of such oil, gas, and sulphur of ingress to or egress from the surface of the Subject Property for the purpose of exploring, developing, or mining of the same, and that such constructing, reconstructing, maintaining, widening, straightening, lengthening, and operating of the Project shall extend across and upon, and will cross, run through, and be upon the Subject Property; and

WHEREAS, an independent, professional appraisal report of the Subject Property has been submitted to the CTRMA, and an amount has been established to be just compensation for the property rights to be acquired; and

WHEREAS, the Executive Director of the CTRMA, through agents employed or contracted with the CTRMA, has transmitted an official written offer to the Owner, based on the amount determined to be just compensation, and has entered into good faith negotiations with the Owner of the Subject Property to acquire the Subject Property; and

WHEREAS, as of the date of this Resolution, the Executive Director and the Owner have failed to agree on the amount determined to be just compensation and damages, if any, due to said Owner for the Subject Property.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the CTRMA that the Executive Director is specifically authorized and directed to acquire the Subject Property for the Project by agreement, subject to approval of the purchase contract by the Board of Directors of the CTRMA; and

BE IT FURTHER RESOLVED that at such time as the Executive Director concludes that further negotiations with Owner to acquire the Subject Property by agreement would be futile, the Executive Director or his designee is hereby authorized and directed to file or cause to be filed a suit in eminent domain to acquire the property interests for the aforesaid purposes against the Owner and the owners of any interest in, and the holders of any lien secured by, the Subject Property described in the attached Exhibit "A" to this Resolution; and

BE IT FURTHER RESOLVED that the Executive Director or his designee is hereby authorized and directed to incur such expenses and to employ such experts as he shall deem necessary to assist in the prosecution of such suit in eminent domain, including, but not limited to, appraisers, engineers, and land use planners.

DAVIS SURVEY NO. 30, ABSTRACT NO. 214, IN AUSTIN, TRAVIS COUNTY, TEXAS AND OUT OF LOT 2, BLOCK A, WATSON ACRES, A SUBDIVISION OF RECORD IN DOCUMENT NUMBER 200700137, OFFICIAL PUBLIC RECORDS, TRAVIS COUNTY, TEXAS, SAME BEING A PORTION OF THAT CERTAIN TRACT OF LAND DESCRIBED AS 4.7178 ACRES IN A DEED TO JIMMY NASSOUR, OF RECORD IN DOCUMENT 2005052232, OFFICIAL PUBLIC RECORDS, TRAVIS COUNTY, TEXAS; SAID 0.682 OF ONE ACRE OF LAND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 1/2" iron rod set with a TEXAS DEPARTMENT OF TRANSPORTATION (TxDOT) aluminum cap, in the proposed south right-of-way (ROW) line of U.S. Highway 290, 215.00 feet right of Engineer's Baseline Station 286+02.43, at the southeast corner of this tract, same being in the east line of said Lot 2 and said Nassour tract, and in the west line of Lot 1, Speedy Stop No. 216, a subdivision of record in Document 200300338, Official Public Records, Travis County, Texas, said Lot 1 being described as Tract 2 in a deed to Speedy Stop Food Stores, LTD., of record in Document 2002105076, Official Public Records, Travis County, Texas, from which point a 1/2" iron rod found at the southeast corner of said Lot 2 and at an interior ell corner on the east line of said Nassour tract, same being the southwest corner of said Speedy Stop tract and said Lot 1 also being in the north line of Lot 3, Block A of said Watson Acres, said Lot 3 being described in a deed to Ernest Karam, Trustee of record in Document 2006009022, Official Public Records, Travis County, Texas, bears S06°01'58"E 33.47 feet;

- 1) THENCE, with the south line of this tract, and the proposed south ROW line of U.S. Highway 290, crossing said Lot 2 and said Nassour tract S84°02'32"W

137.63 feet to a 1/2" iron rod set with a TxDOT aluminum cap at the southwest corner of this tract, 215.00 feet right of Engineer's Baseline Station 284+64.80, same being in the west line of said Lot 2 and in the east line of Lot 1, Block A, of said Watson Acres;

- 2) THENCE, with the west line of this tract and said Lot 2, same being the east line of said Lot 1, Watson Acres, **N05°57'09"W 216.14 feet** to a calculated point at the northwest corner of this tract and said Lot 2 and the northeast corner of said Lot 1, Watson Acres, same being the north line of said Nassour tract *being in the existing south ROW line of U.S. Highway 290*, and the south line of that certain tract of land described as 4.228 acres (Part 1) in a deed to the State of Texas, of record in Volume 3138, Page 2243, Deed Records, Travis County, Texas;
- 3) THENCE, with the north line of this tract, said Lot 2 and said Nassour tract, same being the existing south ROW line of U.S. Highway 290 and the south line of said 4.228 acre State of Texas tract, **N84°02'10"E 137.24 feet** to a calculated point at the northeast corner of this tract, said Lot 2, and said Nassour tract, *same being the northwest corner of said Speedy Stop tract and said Lot 1, Speedy Stop No. 216*, from which point a 1/2" iron rod found bears **N06°01'58"W 0.63 feet**;

- 4) THENCE, with the east line of this tract, said Lot 2, and said Nassour tract, and the west line of said Speedy Stop tract and said Lot 1, Speedy Stop No. 216, **S06°01'58"E 216.16 feet** to the POINT OF BEGINNING and containing 0.682 acres within these metes and bounds, more or less.

All bearings are based on the Texas State Plane Coordinate System, Central Zone, NAD83(93) HARN. All distances and coordinates were adjusted to surface using a combined scale factor of 1.00011.

ACCESS MAY BE PERMITTED TO AND FROM THE TRANSPORTATION FACILITY ACROSS THE PROPOSED RIGHT-OF-WAY LINE AS DESCRIBED HEREIN, BEING THE COMMON BOUNDARY LINE BETWEEN THE PROPOSED U.S. 290 HIGHWAY FACILITY AND THE REMAINDER OF THE ABUTTING PROPERTY.


