## Mobility Authority to Present New Operational Configuration Options for MoPac South at Open House Meeting

**What:** The Central Texas Regional Mobility Authority and the Texas Department of Transportation will hold an Open House meeting on the MoPac South Environmental Study. The study team will share information about several potential operational configuration options, as well as several enhancements that were incorporated into the proposed project as a result of community input. Members of the public can review exhibits, watch informational videos, and submit comments and questions.

All of the information presented at the Open House is available online through the Virtual Open House, which began October 21 and ends November 20. The Open House will provide citizens the opportunity to learn about the potential operational configuration options and to continue to weigh in on the Context Sensitive Solutions for MoPac South. In addition, attendees will be able to review the results of a traffic operations analysis that was conducted to determine how the addition of Express Lanes might impact the downtown street network.

**When:** The Open House meeting will take place Nov. 10 from 3-7 p.m. No formal presentation will be given. The official public comment period is Oct. 21 to Nov. 20, 2015.

**Where:** The Open House meeting will be held at the Palmer Events Center, 900 Barton Springs Road, meeting rooms 1-5, level 2. Parking is complimentary in the Palmer Parking Garage adjacent to the facility with two entrances, from Barton Springs Road or Riverside Drive.
