## OPEN HOUSE SCHEDULED TO PROVIDE UPDATES ON PROPOSED LONG-TERM MOBILITY SOLUTIONS IN OAK HILL

*Opportunity for community to review updated designs and provide input on the Oak Hill Parkway*

**AUSTIN** – The Texas Department of Transportation and the Central Texas Regional Mobility Authority welcome the community to learn more at an open house meeting about what long-term mobility solutions are being proposed in Oak Hill and the surrounding communities.

**WHAT:** The project team will host an open house meeting for the Oak Hill Parkway (US 290/SH 71 through Oak Hill). This is the sixth in a series of open house meetings since the study was launched in October 2012. Attendees will have the opportunity to review and comment on an updated look at the design of Alternatives A and C, including artistic renderings of key intersections, as well as the current evaluation process. Also available for discussion are a series of designs from the team's collaborative approach to transportation design and engineering, known as Context Sensitive Solutions.
