In addition, he provided oversight for Aviation, Code Compliance, and Capital Planning, and served as interim general manager for Austin Energy. During Goode's time serving in local government, he developed and implemented extensive roadway capital improvement programs ranging from \$50M to \$1B. Mr. Goode holds a Bachelor of Science in Civil Engineering from the University of Idaho.

"I am pleased Robert will continue focusing on our region's mobility challenges in this new role and am thankful for his years of service to the Austin community," said Austin City Manager Spencer Cronk. "I look forward to an ongoing partnership with the Mobility Authority and continued opportunities to work with Mr. Goode."

In addition to ten years with the City of Austin, Goode has held various leadership positions in public works and engineering in both the public and private sectors, working for such entities as Travis County, the City of Fort Worth, the City of Olympia, Washington, Bury & Partners, Baker-Aicklen & Associates, and Smith & Kangas Engineers.

"I am excited to join the Mobility Authority and apply my experience to meet the varied mobility needs of the residents of Central Texas," Goode says. "It's a privilege to have the opportunity to help lead this agency through a critical time in its evolution as an innovative leader of industry best practices."
